	Asbestos : containing material or suspected asbestos containing material [†]	DO NOT remove asbestos, Must be removed by a licensed abatement contractor	Contact Charles Gourlay (988-8022) and Taylor Blackley (x7558) for instructions prior to any action
	Freon/Refrigerant containing equipment [†]	Have Maintenance remove all CFC's from the equipment and label	Contact Maintenance (x7199) HVAC will recycle or contact local recycling company for disposal
	Petroleum Products (used oil, fuel, filters, oily/fuel soaked rags)	Used Oil and Fuel: are contracted for removal by Maintenance Oily/Fuel Soaked Rags: Bag and add MU Hazardous Waste Label	Send in an Online EHS Request Form www.methodist.edu/ehs/request.htm or Taylor Blackley (x7558) for pickup

	Fluorescent Lamp Ballasts [†]	Collected and Sorted at Maintenance, MU Universal Waste Label	Fill out a work order on MUNET, MU Maintenance Department (x7199) will handle the removal and proper disposal of Universal Waste Lamps
	Paint: Latex	Keep in original container: Add hardener, <u>if fully hardened</u> dispose of in municipal trash	Questions please contact EHS Office (x7558)
Paint: Solvent Based [†]	Keep in original container: MU Hazardous Waste Label	Send in an Online EHS Request Form www.methodist.edu/ehs/request.htm or Taylor Blackley (x7558) for pickup
